<p>Elmore County</p> <p>Western Idaho Community Health Collaborative</p> 	<p>In August 2023, Elmore County GHI leaders assisted with the hiring of Elmore County's first Community Paramedic, helping launch the Elmore County Community Health EMS (CHEMS) program in September of 2023. CHEMS is a proven model that provides coordinated care to address root causes of preventable and non-emergent 911 calls by providing disease management education, addressing social influencers of health, and doing patient assessments after hospital discharge.</p> <p>In September 2023, the Elmore County Pathways, Trails and Open Spaces Action Plan was published. This plan details the need for improvements to outdoor recreation amenities in Elmore County to improve residents' physical and mental health. The plan also specifies thirteen priority projects that, if undertaken, would have a positive impact on outdoor recreation in the County.</p>	<ul style="list-style-type: none"> • Since September 2023, the Elmore County CHEMS program has seen a total of 97 patients for reasons including, but not limited to, diabetes education, fall prevention, breathing assists, and well-person checks. • In gathering public opinion and feedback for the Elmore County Pathways, Trails and Open Spaces Action Plan, GHI project leaders were able to reach 450 Elmore County residents through surveys, individual interviews, and open house-style forums.
<p>Bannock County</p> <p>United Way of Southeastern Idaho</p> 	<p>January 2023 Bannock County GHI project leaders launched its pilot program Ride United, which offers free transportation for health-related activities for community members who are patients of the county's free clinic, crisis and recovery centers, and mental health providers.</p> <p>In December 2023, Ride United celebrated ONE YEAR of providing free health-related rides to community members in need.</p>	<ul style="list-style-type: none"> • 2023, Ride United delivered 2,432 total rides (14,442 total miles) to promote access to health and health-promoting services. • 2023, GHI project leaders successfully launched three public awareness campaigns about Ride United through TV, radio, newsletters and social media.
<p>Kamiah/Orofino</p> <p>Clearwater Economic Development Association</p> 	<p>In October 2023, the Clearwater River Corridor Collaborative kicked off the first of its monthly GHI meetings with multi-sector, regional partners. The CRC Collaborative includes representatives from two area hospitals, the Idaho Food Bank, elected officials, local public health, community developers, education, and youth organizations.</p>	<ul style="list-style-type: none"> • The Collaborative will build on existing health care and related regional assessments in north central Idaho, focusing on the communities of Orofino and Kamiah, to identify community health priorities.

Idaho's State Health Improvement Plan (aka Get Healthy Idaho), highlights the state's greatest health challenges and charts a path to collaboratively address them with partners and stakeholders.

Results Based Accountability™ (RBA):

A data-driven, decision-making process to strategically move to greater action. Starting with the "ends" in mind (what difference are we trying to make?), GHI team worked with staff to develop an actionable plan to address four priority health challenges: Behavioral Health, Diabetes, Obesity, and Unintentional Injury.

GHI Team: Year in review



The Get Healthy Idaho strategy is built around three pillars:

- 1) Using data to identify needs;
- 2) Cultivating local partnerships to build capacity and empower transformational change; and
- 3) Investing in people and partners who know what works to improve health at the community level.

GHI empowers community collaboratives to identify the root causes of health challenges that prevent community members from being as healthy as possible. Each funded community develops and implements unique, local plans that incorporate solutions to improve health. GHI provides funding that transforms systems and leads to sustainable improvements in health where no additional funding source is available.

In addition to funding communities, the GHI team supports, participates in, and leads numerous efforts and partnerships working to promote, protect, and improve the health of Idahoans.

Spring Highlight

Finalized the GHI-Health Improvement Plan Update in April with leadership final approval and publication in June. The plan update was submitted to the Public Health Accreditation Board (PHAB) as an example of the Division’s alignment with re-accreditation requirements for statewide health improvement planning.

Autumn Highlight

Kicked off the 5-year Statewide Health Assessment cycle with a review and synthesis of 32 current Community Health Needs Assessments and population health assessments covering nearly every community in Idaho.

Summer Highlight

Released opportunity to fund a third GHI community in North Central Idaho in May. Four proposals were received. Awarded funding to the Clearwater Economic Development Association (CEDA) focused on the communities of Kamiah and Orofino in the upper Clearwater River Valley.

Winter Highlight

Get Healthy Idaho was recognized by ASTHO in a December [blog post](#) for creatively utilizing the CDC’s PHHS Block Grant to support Social Determinants of Health and health equity initiatives.
